- The annual government fee is not prorated and is billed in October each year and paid to the government in January of the following year together with the annual filings.

General Fee Information

- Company fees are billed in advance upon incorporation and annually thereafter. Due to the nature of the service provided fees are generally not refundable.
- Work performed in addition to the services described above will be charged at our standard rates applicable to the personnel performing the work. Such time will be billed in arrear either monthly, semi-annually or annually depending upon the volume of work performed.
- Hourly rates for additional services:
 - Directors \$300 - 650
 - Professional Staff \$150 - 300
 - Semi-Professional Staff \$100 - 150
 - Clerical Staff \$50 - 100
- Special transaction fees may be charged for work of a particularly onerous, time critical, high value or otherwise exceptional nature.
- Time spent reviewing the initial submission due diligence documents and ongoing review of such documents will be charged on an hourly basis.
- We reserve the right to charge additional fees on a time spent basis for those services which are normally charged at a fixed fee rate, where our duties involve a volume of activity or complexity not envisaged by the fixed charges.
- To ensure that all January company filings are made in time fees should be paid no later than December 31. Government penalties of up to 100% of the annual fee are applied on a sliding scale for late payments.

Fee Schedule Companies

- The above fee schedule excludes disbursements which are billed separately. Routine disbursements, which include phone, fax, email, photocopying, scanning, printing, postage, document retention and disposal costs are charged at a flat rate of 7.5% of time spent on an engagement. Other disbursements are billed on an actual cost incurred basis.
- Additional government fees may be payable depending on the activities of the entity.
- Please contact our offices for further details on services and fees not included on the fee schedule.
- The company may retain brokerage, insurance or any other commissions received in the normal course of its business.
- Fees and expenses are quoted and payable in US dollars.
- Fees are subject to annual review.
- The Registered Office fee includes providing the local Registered Office and filing of the annual corporate return with the Registrar of Companies; preparing the annual statutory minutes of meetings and preparing proxies for annual meetings, where applicable.
- Annual fees are payable in advance on formation and are billed annually in advance in October each year pro rated as necessary.
- A minimum fee of \$1,350 plus \$100 in related expenses is payable for services performed in connection with the appointment of Trident Trust Company (Cayman) Limited as the successor Registered Office for an existing Cayman Islands company.
- A minimum fee of \$1,350 plus \$500 in related expenses will be charged for the striking off of a Cayman entity from the Registrar.
- A minimum fee for a company closure by way of lapse is \$600.
