### Registry Focus on Private Aircraft

The Registry's objective is to provide an Aircraft Register for privately owned, non-commercial jets, aeroplanes and helicopters. Aircraft on the Register may not carry passengers for payment.

### Advantages of Isle of Man Aircraft Registration

- **Location** The Isle of Man is located within the European time zones; competing offshore aircraft registers are based in the Caribbean.
- **Financial Stability** The jurisdiction is AAA rated by Standard & Poor's.
- **Favourable Tax Regime** Isle of Man companies are taxable at a rate of 0% with no local capital gains tax, stamp duty or wealth taxes.
- **Competitive Fees** The Registry's services are competitively priced to attract business to the jurisdiction.
- **Security** The Isle of Man has an efficient mortgage register.
- **No Insurance Premium Tax** Absence of this tax leads to lower aircraft operating costs.
